- Instructions:**
- 1) A conservator may use this form to petition for authority to a) terminate a tenancy or lease, b) change the residence (except for the placement in an institution for long term care from a less restrictive environment) and/or c) sell or dispose of the household furnishings of a person under conservatorship as required by C.G.S. section 45a-656b.
  - 2) If the change of residence involves a placement in an institution for long term care from a less restrictive environment, this form may not be used. The conservator must file a report and petition for placement in the institution for long term care, PC-371A.
  - 3) For any other change of residence, the conservator may use this form to report a proposed change of residence. The conservator must send a copy of this petition by first-class mail to the person under conservatorship, the attorney for the person under conservatorship and any other party, to notify them of the proposed change of residence as required by C.G.S. section 45a-656b.
  - 4) The petition is required to be filed in both voluntary and involuntary conservatorship proceedings.
  - 5) Type or print the form in ink.
